
Sub: **UPDATION OF COURT CASES AT LEGAL INFORMATION MANAGEMENT & BRIEFING SYSTEM (LIMBS) PORTAL**

The undersigned is directed to all the Users of LIMBS of CWC(HQ) & Field offices of CWC to follow the following points related to updation of Court Cases at LIMBS Portal:

1. All the Chief Engineers of field and US/SO of CWC(HQ) may be initiated to activate the remaining Users at LIMBS.
2. Contempt Court Cases may be maintained properly by the Users.
3. Others Court Cases at LIMBS must be shown their State-wise etc.
4. All the information such as Court's Name etc. at LIMBS may be corrected by the Users.
5. Advocate payment must be paid online.
6. Important Court Cases can be marked by Users.
7. Draft Court Cases at LIMBS Portal should be completed at the earliest. Because Draft Court Cases are not shown on the LIMBS Portal and could not be analysed by the LIMBS Team. Moreover after stipulated period, draft Court Cases will be removed by the LIMBS Team from the Portal. To move the Draft Court Cases/s in the streamline of Portal, next date of hearing or in case of not availability of next date of hearing, **target date** must be uploading against such draft Court Cases.
8. For any help, HELP DESK mode is available at LIMBS Portal.
9. Decided court cases should be move to Archive at LIMBS Portal.
10. A certificate regarding updation of Court Case/s at LIMBS Portal may be submit to the undersigned by **8th August, 2017**.
11. Those Users of LIMBS Portal at CWC(HQ) or Field offices, who are still facing any problem, a LIMBS Training will again be held at Committee Room No.307(S), 3rd Floor, Sewa Bhawan, R.K. Puram, New Delhi on **18th August, 2017(Friday)** at 11 AM onward.

It is, therefore, requested that all the LIMBS Portal Users of CWC(HQ) & Field Offices of CWC must implement the above said points at the earliest and such Users, who are still facing any difficulty to update the Court Cases at LIMBS Portal, may send their confirmation to attend the above LIMBS Training Programme to the undersigned latest by **10th August, 2017**.
