

TERMS AND CONDITIONS


1. Each bidder shall submit only one quotation. Normally, the lowest rates quoted will be accepted.
2. Only those firms who are using good quality of materials as stipulated in the Indian Standards and who will be able to execute the work within the stipulated period need to quote the rates.
3. The material shall be accepted only after due inspection by the office of CWC during construction and before finishing. Usage of any substandard material if noticed will make the work liable to be rejected by CWC schedule of work program shall be intimated for arranging inspection. All the eraser mistakes, over writings should be duly attested.
4. Bids shall be accepted only offline.
5. Quotation placed in a sealed envelope, with the name of the work and due date written on the envelope will be received by the **SUB-DIVISIONAL ENGINEER, UPPER BHIMA SUB DIVISION, CWC, PUNE** up to **15:00 hrs on 31/05/2019** and will be opened on the same day at **15:30 hrs**.
6. The competent authority on behalf of President of India does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the tenders received without assigning any reason. And also reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
7. The tender document for free can be downloaded from the website @ www.eprocure.gov.in <http://www.cwc.gov.in>.
8. The Tender rates shall be remained valid up to 90 days only.
9. Rates must include all liabilities & taxes as applicable. No extra charges will be paid other than the rates approved.
10. **Correction & over writing shall be duly attested.**

11. **EMD @ 3 %** of the Estimated amount of the work i.e. Rs. 2637.00 (Rupees two thousand six hundred and thirty seven only) shall be enclosed in the form of Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the Commercial Banks or payment online in an acceptable form drawn in favour of the Executive Engineer, Upper Krishna Division, CWC, Pune payable at Pune. EMD of un-successful bidders will be returned immediately after finalization of bids without interest. The EMD of the successful bidders will be adjusted with the security deposit to be deposited by the successful bidder. EMD exemption for Micro and small enterprises (MSEs) as defined in MSE Procurement policy issued by Department of Micro, Small and Medium Enterprises (MSME) or are registered with the Central Purchase Organisation or the concerned Ministry or Department.
12. Performance security deposit of 5% of the quoted cost will be retained at the time of payment and the same will be released after six months or full monsoon whichever is later after checking the worthiness, trouble free performance of water proofing treatment of the existing terrace and stability at different working conditions.
13. The time allowed for carrying out the work will be 30 days from the day after the date of written order to commence the work or from the first date of handling over of the site whichever is later.
14. All quotations in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
15. The quotation for the work shall remain for acceptance for a period of 90 days from the date of opening of quotation. If any tenderer withdraws his quotation, then the government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid.
16. All the debris and un-used materials etc. should be removed from the work site as soon as the work is completed. No extra charges will be paid for this purpose.
17. After satisfactory completion of the works in all respects, the bill in triplicate may be submitted for payment to the undersigned. The payment will be made by **PFMS/RTGS**.
18. Income tax and other taxes as applicable shall be deducted from the bill.
19. The Contractor must submit the proper **Registration and work permit, PAN/TIN/Service Tax number/GST No.**
20. This department is not responsible for any accidents / losses to workers engaged in the work
