Dear Serve Tony,

The Delhi State Election Commission will be holding the General Elections to the three Municipal Corporations in the month of March/April, 2022. For this purpose, the Delhi State Election Commission has projected the requirement of a total manpower of 1, 46, 500 for forming 26,500 Polling parties (comprising 5 officials in each party) and 3500 Reception Parties (comprising 4 officials in each party). The Chief Secretary to the GNCTD has informed that the Delhi Government will be able to arrange 18500 parties out of its own resources; and requested to provide 10000 Polling parties and 1,500 parties for Reception and Counting Duties. During the 2017 Municipal Elections the Government of India had provided 6100 parties, which included manpower from CPSUs and other Bodies under the Central Government. The polling staff will be required for a total period of 03 days, and the schedule of which will be finalized by the State Election Commission. Each of the Parties will comprise of the following:



Sub: Regarding deployment of staff for Polling Parties from Central Government Ministries / Departments/ PSUs to conduct General Elections to the three MCDs to be held in March-April 2022.

I am directed to refer to DO No. F.2/12/2021/S.I/2714 dated 15.12.2021 from Chief Secretary, Govt. of NCT of Delhi and DO No. 14011/29/2021-Delhi-II dated 12.01.2022 from Home Secretary Govt. of India for providing of 10000 polling parties and 1500 parties for reception and counting duties.

The Commission vide letters 18.01.2022 & 28.01.2022 has already requested to provide the Ministry wise / Department wise allocation of polling parties with details of Nodal Officers (Copy enclosed). The requisite information is still awaited.

During the 2017 Municipal Elections, the Govt. of India has provided 5115 polling parties which included manpower from CPSUs and other bodies of the Central Govt. A list indicating names of 116 Departments/PSUs/other Bodies which provided the polling staff alongwith number of polling parties in 2017 and tentative estimates of agency wise polling parties required this time in view of the increased requirement of 10000 polling parties is enclosed for ready reference.

So far details of Nodal Officers have been received only from 50 departments and only 07 departments have provided details of polling staff. In fact, the Commission has to prepare Polling Parties on the basis of information of Polling Staff to be provided by the concerned Nodal Officers. The Commission is facing difficulty in processing the matter since Ministry-wise / Departments wise / CPSUs wise allocation of Polling Parties has not been provided by the Ministry of Home Affairs to the Commission. In absence of inter-Agency allocation it may not be possible for the Commission to access the sufficiency of the staff provided by the Agency/ Department. Also, many Ministries/Departments/CPSUs have not yet given the details of Nodal Officers at secdelhipollingparty@gmail.com



Therefore, I am directed to request you to arrange to provide the following:

- 1. Ministry-wise/ Departments wise/CPSUs wise allocation of polling parties.
- Details of Nodal Officers at <u>secdelhipollingparty@gmail.com</u> for issuance of user i.d. and password to them.
- 3. Details of Polling Staff populated by the Nodal Officer at given web link: secdelhi.in .

Your kind intervention would help us to prepare the polling parties/counting parties for the forth coming Municipal Elections.
