I am directed to refer to the fourth Quarterly Review Meeting ((QRM) held on 21st November, 2023 under the Chairmanship of Chief Engineer (HRM), CWC to review the important issues relating to the HRM Wing and the action taken on the points that emerged in the third QRM.

- 2. In the said meeting, it was observed that as the service verification of officials who completed of 18 years of regular service and before 5 years of retirement is not being made in time. This delays the processing of pension cases and release of retirement benefits to retired government employees.
- 3. Thus, it was decided in the fourth QRM that data on service verification of the officials of CWC on completion of 18 years of regular Service and before 5 years of retirement may be obtained from Field Offices of CWC and a consolidated data may be furnished to Establishment-IV Section, CWC within 15 days of the meeting to review the service verification cases.
- 4. Therefore, it is requested to furnish the consolidated data (Chief Offices wise) of Service Verification i.r.of Assistant Director Gr.-II/Sub Divisional Engineer who are posted at Field Offices of CWC in the enclosed proforma to this Section, by email latest by 15th December, 2023, so that the consolidated data may be furnished to Establishment IV Section, CWC for further necessary action at their end.
