Minutes of the meeting on issues regarding development of e-PAMS held under the chairmanship of CE(PAO), CWC on 15.03.2018

A meeting to review the progress regarding development of e-PAMS was held under the chairmanship of CE (PAO), CWC on 15.03.2018 from 15:00 hrs onwards in the 3rd Floor Committee Room of CWC.

The list of participants is given at enclosed Annexure.

At the outset, the Chairman welcomed all the participants and directed to start the deliberations while simultaneously impressing upon all concerned to adhere to the timeline of **01.07.2018** fixed by Secretary (WR,RD&GR) in the meeting taken by him on 19.02.2018.

Officers from NIC presented on screen the development made so far in the e-PAMS portal pertaining to Irrigation and Multi-Purpose Projects. Director (Technical), NIC present in the meeting stated that NIC will complete the development of e-PAMS by 15 May 2018 and thereafter till 30.06.2018, NIC will help CWC in imparting e-PAMS training to all concerned so as to make them familiar about this portal. During this period from 15.05.2018 to 30.06.2018, the internal security audit of NIC will also be undertaken.

Director-PA(C) requested the NIC officers to provide weekly physical and financial progress in development of e-PAMS to CWC. Director (Technical), NIC acceded to this request. NIC officers were also requested to provide the **weekly schedule** during which the software development on other sections of e-PAMS viz. FMP/Coastal Protection Schemes/Projects of CWC and FMP Schemes of GFCC will be undertaken by NIC so that the concerned officers from CWC and GFCC may be kept on readiness for interaction with NIC, if needed, and also for monitoring of progress by Secretary (WR,RD&GR).

CE(PAO), CWC urged the concerned officers from FMP, CWC and GFCC to be ready to make visits to NIC as and when required by the developer and suggest further refinements, if any, in the online portal as per their workflow.

CE(PAO), CWC desired that internal training of concerned CWC officers may be carried out from 15-30 May 2018 and training for external users i.e. State authorities may be carried out from 01-30 June 2018. NIC will clear all the garbage data fed into the portal during internal/external drill/training by 30.06.2018 so that e-PAMS will be launched on 01.07.2018 as desired by Secretary (WR,RD&GR).

The CWC officers present desired that the comments/observations shall be inter-visible to all the specialised directorates of CWC and that there shall be Print option at every stage of online submission and appraisal of project proposals.

CE(PAO), CWC expressed his displeasure on non-participation of some of the officers from the concerned directorates of CWC and urged them to be attentive in future meetings in view of the priority assigned to the development of e-PAMS. Further, it was also emphasised that other components of e-PAMS including Flood Control, Coastal Erosion, External Assistance etc. may be monitored for progress thereof in e-PAMS by the concerned authorities in MoWR,RD&GR with more intense efforts.

The meeting ended with a vote of thanks to the Chair.
