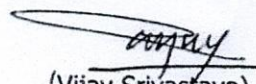

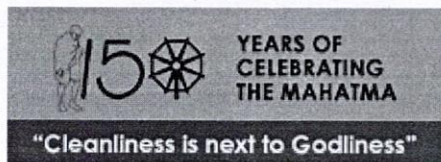

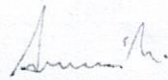

2. The proposal has been examined in consultation with Budget Division of Deptt. of Economic Affairs and it is informed that this Department agrees to the aforesaid re-appropriation proposal subject to compliance of Rules 65 (2) & (3) of GFRs 2017, the proposal is within the overall RE. However, as regards FRBM relaxation Budget Division of Deptt. of Economic Affairs has intimated the following:-

*"...in terms of instructions issued by this Department vide O.M. No. 12(15)-B(W&M)/2019 dated 27.12.2019, relaxation of expenditure ceiling in the last quarter/last month of FY 2019-20 is required only for overall expenditure in the Demand. The same is not required for individual scheme".*

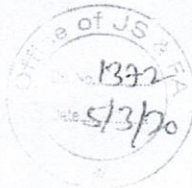

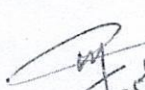
