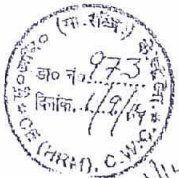
Modification of Para 5(i) of the Scheme for grant of Temporary Status and regularization of Seasonal Khalasis in the workcharged establishment of Central Water Commission.

Sir,

I am directed to say that in accordance with Hon'ble CAT's Order dated 18th October, 2014 in various OAs; Scheme for grant of Temporary Status and regularization of Seasonal Khalasis in the workcharged establishment of Central Water Commission circulated vide Ministry's letter no. 8/3/1995-E.I (vol-II) dated 20th June, 1997, has been examined in consultation with DoP&T and D/o Legal Affairs.

2. It has been decided to amend para 5(i) of the Scheme as follows:-

Para	Existing Provision	Revised Provision
5(i)	Temporary Status will be conferred on all those Seasonal Khalasis engaged on workcharged establishment of the CWC on the date of commencement of the Scheme or any time during the preceding one year and have rendered a minimum of 120 days continuous service preceding such date.	Temporary Status will be conferred on all those Seasonal Khalasis engaged on workcharged establishment of the Central Water Commission on the date of commencement of the Scheme or any time during the preceding one year and have rendered a minimum of 120 days continuous service. Note: For this purpose, 120 days should be reckoned taking in account various spells of engagements as Seasonal Khalasis provided the gap between two spells of employments has been caused due to the season being over and the department itself directing them not to come to work in that season after particular specified date. However, if a person engaged in the previous year is given an opportunity to work in the same department in the subsequent year, but he fails to avail of this opportunity, he shall have to start afresh in the event of his being so engaged again in any future season.
