Minutes of Meeting

The 9th meeting of National Committee on Dam Safety (NCDS) was held on 7th November 2024, under the chairmanship of Shri Rakesh Kumar Verma, Chairman, CWC & NCDS. The meeting was held in virtual mode. The list of participants is attached as **Annexure-1**.

At the outset of the meeting, Chairman, NCDS and CWC welcomed all the participants in the 9th meeting of NCDS. Chairman of the committee informed the committee members that the agenda for the meeting is to discuss the draft **Standard operating procedure (SoP) prepared for Comprehensive Dam Safety Evaluation (CDSE).** Chairman of the committee invited all the participating States, Members of the for their suggestions/comments on the draft SoP. Accordingly, Member Secretary, NCDS presented the power-point presentation on the agenda point stated above.

9.1 Deliberations and Decision:

During the detailed contemplation on the draft SoP, few committee members were of the view that conducting CDSE exercise only for the selected dams as mentioned in the draft deviates from the provision of the act. However, Chairman of the committee apprised the members that the tiered approach adopted in the draft SoP is not an elimination process, rather a prioritization scheme. He suggested to incorporate the necessary changes in the SoP for the same.

Further, a point was emerged out of the deliberation that there is a need for revision of current dam safety related guidelines and manuals in the country. However, no specific issues with the guidelines came into light. In this regard, the committee agreed to start the process of reviewing already framed guidelines.

Decision: The proposed draft Standard operating procedure (SoP) for Comprehensive Dam Safety Evaluation requires modification as per discussion and revised draft may be placed for consideration in the next NCDS meeting.
