OFFICE MEMORANDUM

Subject: Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 regarding details of Procurement from MSEs.

This is with reference to Public Procurement Policy for MSEs order, 2012 whereby an overall procurement of minimum of 20% of goods and services has become mandatory w.e.f. 1st April, 2015. A sub target of 4% out of the 20% target of annual procurement has also been earmarked for procuring from MSEs owned by SC/ST entrepreneurs.

The procurement data are required for replying to possible enquiries/ questions asked by the Department related Parliamentary Standing Committee on Industry. The data so compiled also serves as an important input for monitoring the Policy.

It is, therefore, requested that requisite data in respect of your Ministry /Department and CPSUs under your administrative control may kindly be made available to this office at an early date, in the enclosed prescribed proforma (Annexure-A)
