2. The sealed bids should be dropped in the tender box placed in the office of the Executive Engineer, Mahi Division, CWC, 3rd Floor, Narmada Tapi Bhawan, Sector-10A, Gandhinagar on or before 28.02.2016 by 3.00 PM and will be opened on the same day at 3.30 PM in the office of the Executive Engineer, Mahi Division, CWC, 3rd Floor, Narmada Tapi Bhawan, Sector-10A, Gandhinagar. Intending bidders may be present at the time of opening of Bids.
3. The rates/ amount shall be quoted in figures & words separately for each item/ lot as mentioned in financial bid. **Bids will be evaluated on consolidated rates.** Item wise evaluation will not be done. Taxes & other levies, freight if any, will have to be borne by the bidder.
4. CWC will not entertain any claim for damage done by way of theft, pilferage, fire or any other unforeseen calamity after realizing full payment against the sale of unserviceable items.
