

The Successful bidder (i.e. highest bidder) shall be required to deposit the balance of the Sale value (i.e. highest bid-EMD) within 5 (Five) working days from the date of issue of acceptance of the bid through Cash/Demand Draft drawn in favour of Executive Engineer, Lower Ganga Division, CWC payable at Patna.

The Said unserviceable materials must be removed by the successful bidder within 5 days from the date of issue of acceptance of the bid after making payment of the full bid money, failing which earnest money will be forfeited.
