The sealed envelope containing the quotation should be super scribed as "*Digitization of Contour Maps of Tlawng HEP under NEID-II, CWC, Aizawl due on 30-07-2022*" and addressed to the Executive Engineer, North Eastern Investigation Division-II, Central Water Commission, Zemabawk, Aizawl(Mizoram)- 796017.
2. The rate should be indicated in both figures and words. The quotationers shall initial corrections/ overwriting if any in the quotation.
3. The sample of drawings may be collected/seen at the O/o the undersigned on all working days up to 30-07-2022 during office hours from 10 am to 5 pm.
4. The quantities mentioned in the Schedule of Quantities are tentative only and may vary at the time of placing the work order subject to requirement.
5. The quotation shall remain valid for a period of not less than 90 days from the date of opening.
6. The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered lowest price.
7. The vendor shall be required to undertake full responsibility of the safe custody and to maintain secrecy / proper care of drawing/ data and each drawing and data given by the this

office will have to be kept strictly confidential and no part of it shall be divulged to any person at any time without written authorization from this office. In case of lapse, the vendor will be fully responsible for the consequences.

8. The vendor shall be responsible for prepare hand traced contour maps in Auto-CAD software and shall submit this office in soft copy. In case of any damage occurred to the drawing during the process, the same should be informed to undersigned without delay by the vendor.
9. In case the digitization work carried out is not according to the specification mentioned in the work order, the work will have to be redone. No extra payment shall be made for this.
10. The Digitization of Contour Maps should be done as per quotation within 45 days from the date of issue of work order.
11. The rates should be inclusive of all local taxes such as Service Tax/GST etc.
12. The undersigned reserves the right to cancel/reject in part or full or any/all the quotation without assigning any reason thereof and without any financial involvement from either side.
13. The payment will be made after satisfactory completion of work only. Payment will generally be made via online mode through PFMS directly on the bank account of the bidder on production of bills after submitting soft copy of Auto CAD drawing to this office.
