- 1. The quotations duly signed should be properly sealed and either dropped in quotation Box in the office of the Executive Engineer, Chenab Division, Central Water Commission, Jal Aayog Bhawan, Rajinder Nagar, Bantalab, Jammu or send by speed post to this office. The sealed envelope should be super scribed "Quotation for Providing and laying Mild Steel Drain Cover in the office complex, Chenab Division, CWC, Jammu"
- 2. In the event of the date of opening of quotation being a holiday, quotations will be opened on the next working day with timings unchanged.
- 3. Quotationers must have PAN and Goods & Service Tax number. Registration certificate of Firm. Photocopy of the same should be enclosed.
- 4. Rs. 3864.00(Rupees three thousand eight hundred sixty four) only as Earnest Money Deposit (EMD) of tender through A/C payee Demand Draft or FDR, CDR, TDR (Refundable) drawn on any schedule bank in favour of the Executive Engineer, Chenab Division, CWC payable at Jammu.

- 6. The undersigned does not bind himself to accept the lowest quotation and reserve the right to accept or reject any or all the quotations without assigning any reason thereof.
- 7. The work should be done as per CPWD specification & direction of Engineer in charge.
- 8. All the correction and overwriting should be duly attested.
- 9. Canvassing whether directly or indirectly is strictly prohibited.
- 10. The material should be as per Indian standard and free from defect and if found not suitable, the same may be asked for replacement.
- 11. The undersigned reserves the right to reject or accept partly or fully any or all quotations without assigning any reason thereof.
- 12. Pre-receipted bill in duplicate may be submitted after satisfactory completion of work.

- 13. Work should be completed within 30 days from the date of issue of Work order.
- 14. Rates quoted should be valid at least for 60 days from the date of opening.
- 15. The payment will be made through PFMS after satisfactory supply of the materials in good condition and as per specification. For this, the quotations must submit their Bank Account Details such as Account No., Name of the Account Holder, Name of the Bank and Branch, IFSC Code and address of the Branch.
- 16. No advance payment shall be made. However the payment shall be released only after the end of services/Works are satisfactory.
