### **Terms & Conditions:**

1. The quotations along with brochure confirming to specification duly signed should reach this office on or before **23/08/2020 upto 15:00 hrs and will be opened same day at 15:30 hours** in the presence of the supplier or their authorized representatives whom so ever will remain present at their own cost at the time of opening.
2. The Quotationers should clearly indicate their TIN, GST & PAN Numbers.
3. The prices quoted shall be F.O.R .Jaipur i.e. (office of the Executive Engineer, Chambal Division, CWC, Ajay Marg, Pratap Nagar, Jaipur-302033) and inclusive of all duties and taxes including freight charges, GST and Other taxes etc. and no additional amount on the quoted prices shall be paid on account of such duties and taxes etc.
4. The rates & amount shall be quoted in figure as well as in words.
5. All cutting/ Overwriting should be countersigned/ initialed.
6. The undersigned reserves the right to reject any or all the quotations without assigning any reasons thereof.
7. Rates should have a validity period upto 60 days from the date of opening of quotation.
8. The quantity will be decreased or increased at the time of supply for which the agency should bind to supply the material on quoted rate.
9. The supply should be completed within 30 days from the date of the issue of supply order
10. The material should be of standard quality and free from defect and if found not suitable the same shall be asked for replacement at the cost and risk of the supplier.
11. Intimation of unsuccessful quotation will not be given to concerned Firms and the quotationers shall have no claim of any nature on this office.
12. On acceptance of the quotation, the agency shall have to submit performance Security @ 3% of the tendered amount in the form of an Account Payee D.D/ Fixed Deposit

Receipt/ Banker's cheque or Bank Guaranty from any of the commercial bank in favour of Executive Engineer, Chambal Division, CWC, Jaipur payable at Jaipur. This should remain valid for a period of sixty days beyond the date of completion of all contractual obligations including warranty obligations. On receipt of the Performance Security the Bid Security is liable to be released.

13. In case if the firm fails to supply the material, as per the specifications/ requirements and terms and conditions after quoting the rates for items then supplier will be banned for future transaction.
14. The Performance Security of the successful quotationer is liable to be forfeited in case, not supplying the material on the issue of confirm order.
15. Pre-stamp receipt bill in duplicate should be submitted after completion of successful supply of materials and payment will be released only after the receipt of materials in good and satisfactory condition at our end, through PFMS within 15 days.
16. Taxes as applicable will be deducted at the source from the bill at the time of payment.
17. Canvassing in any form whether directly or indirectly is strictly prohibited.
18. **Minimum 1 year on-site warranty should be given on the supplied materials.**
19. In case of any dispute, the decision of undersigned will be final and binding.
