- 7. The rates shall be valid for 60 days minimum from the date of opening of the quotation.
- **8.** The work shall be carried out within 30 days from the date of issue of the Work Order. Extension of time will be allowed only after submission of sufficient reasons of delay.
- 9. The payment will be made through PFMS after actual measurement of work on successful completion for which bill in triplicate shall be submitted to this Office.

- 11. All the corrections and over writings should be duly attested.
- 12. Taxes as applicable will be deducted from the bill at the time of payment.
