- 8) The boat fitted with 25 H. P engine operated by boatman on hire charges basis for taking hydrological observation once in everyday (excluding Sunday and holidays) and period of the engagement shall be reckoned on the basis of actual engagement in the work.
- Claim/ claims for damages or loss of boat/ 25 H.P engine and life due to accident or otherwise either natural calamity or other reasons whatsoever shall not be entertained by the department.
- 10) Responsibility of safety and securities of boatman during hydrological observation in water i.e. in the river will entirely rest with the suppliers.
