- 2. Only those firms having GST number are eligible to submit their quotation.
- 3. The undersigned does not bind him to accept the lowest quotation and reserve the right to accept or reject any or all the quotations without assigning any reason thereof.
- 4. All materials required for the work are to be supplied by the contractor. The material must be of standard quality and as per specifications and free from all defects. The material if found defective subsequently or not conforming to the specifications as stated above, have to be replaced by the firm without any additional charges.
- 5. Before starting the work, material shall be got approved from the Sub-Divisional Engineer, MID, CWC, Shillong.
- 6. The work shall have a warranty period of minimum six months from the date of installation.
- 7. The work is estimated to cost ₹ 1,98,000/- (Rupees One lakh ninety-eight thousand only). This estimate, however, is given merely as rough guide.
