## Desirable conditions for carrying out studies:

### 1. Preliminary Canal Alignment:

- The canal to be aligned on the ridge/contour in such a way as to serve the maximum command with optimal length.
- The alignment should avoid inhabited places, roads, railways, properties, places of worship etc.
- Canal should be taken through the area where subsoil formation is favorable. Water-logged, alkali, saline, rocky soils may not be suitable for canal.
- The alignment should be straight as far as possible. In case of unavoidable circumstances simple circular curves of large radius should be provided.
- The alignment should not cross hills or depressions so that that excessive cuttings and fillings are avoided. However, in unavoidable circumstances alignment shall be planned in such a way so that cutting & filling is balanced.
- While aligning the canal, cost of the land to be acquired (as per prevalent circle rates) should be taken into consideration.
- The canal should cross minimum number of drainages to minimize CD works.
- Extant BIS Codes (e.g. IS 5968 etc) and CWC Guidelines shall be adhered to while carrying the Canal Alignment Studies.

### 2. Environment Impact Assessment:

The environmental studies must include following:

- General environmental conditions of the state
- Regulations & policy framework
- Specific environmental conditions of the project area
- Potential environmental impact & mitigation measures
- Preliminary findings and conclusion/recommendations

### 3. LULC Mapping:

- LULC map shall be prepared separately for Command area and Reservoir Area.
- LULC should clearly depict various land use features viz. Agricultural land, Barren Land, Tea Garden, water bodies, settlement etc. and quantification of land use pattern shall be provided.
- Map shall be provided in pdf file as well as GIS compatible file.
