- iii) The sealed quotation should be superscribed as "PROVIDING STEPS TO REACH STATION GAUGE LINE IN RIGHT BANK AT SITE THOTTATHINKADAVU UNDER CSD, KOZHIKODE and should be addressed to the Executive Engineer, South Western Rivers Division, Central Water Commission, Jaldhara,D.No. 27/1927-A, Kasturba Nagar, P.
