

Terms & Conditions:

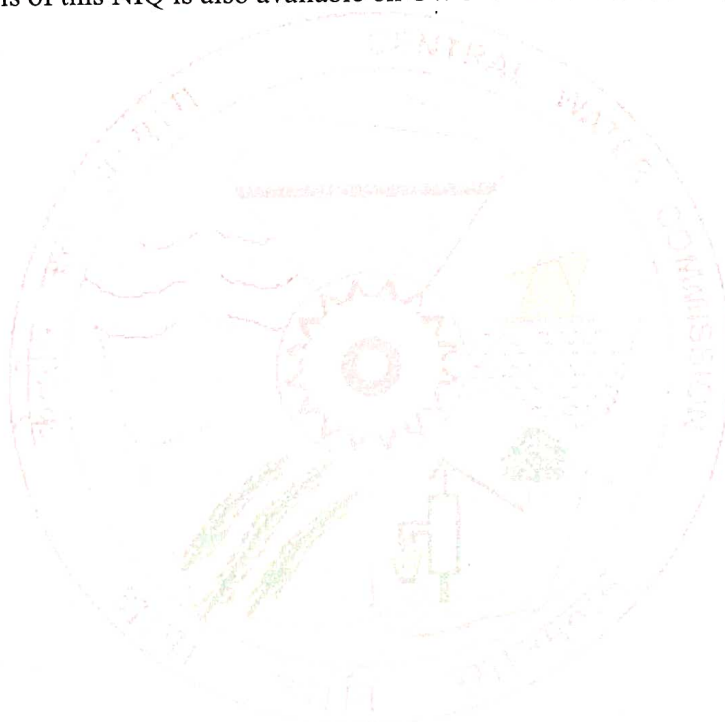
1. The supply of items should be completed as per specification within 3 (Three) days from the date of issue of the supply order.

Quotation may be dropped in the Tender/Quotation box kept in the office of the undersigned or may be sent by the registered post. (Marked as quotation for Supply of 15 (Fifteen) Xerox Print Cartridge) to the undersigned so as to reach on or before the date and time stipulated for receiving the quotation. No quotation will be entertained after the stipulated time.
