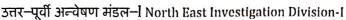
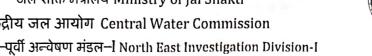

Terms & Conditions:

- The supply of items should be completed as per specification within 3 (Three) days from the date of issue of the supply order.
- 2. The rates shall be kept valid for minimum period of 60 days from the date of opening of quotation.
- 3. The rate should be inclusive of all local taxes such as VAT etc.
- 4. Rates of GST should be mentioned as applicable.
- 5. The rate of items should be quoted both in figure and in words.
- 6. The quotation number with date of its opening has to be clearly mentioned on the top of the quotation and sealed cover. Quotation may be dropped in the Tender/Quotation box kept in the office of the undersigned or may be sent by the registered post. (Marked as quotation for Supply of 15 (Fifteen) Xerox Print Cartridge) to the undersigned so as to reach on or before the date and time stipulated for receiving the quotation. No quotation will be entertained after the stipulated time.
- 7. Any correction in the quotation should be clearly attested.
- 8. Request for any advance payment will not be entertained.
- 9. The supply carried out by the firm shall be guaranteed for a period as per manufacturer policy.
