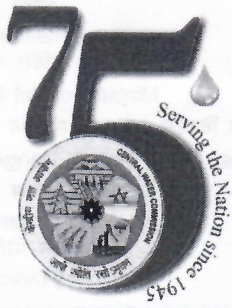



8. The Successful bidder will return the dashboard/plate bearing vehicle identification Number (VIN) or chassis/Engine No. at the time of delivery of the vehicle.



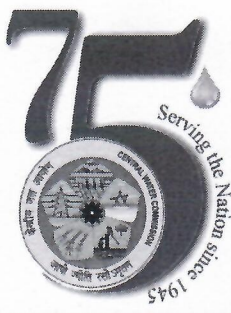
