- The Sealed quotation cover should be super scribed with the words "CISCO- Webex (Video Conferencing and online meeting software) with 1-year Subscription."
- The bidders shall submit the signed and scanned copies of technical documents i.e. copy of supply orders, PAN, GST, etc latest by 1500 Hrs on 13.08.2024.
- Rates shall be quoted as per BOQ-PS mentioned in Annexure-I & inclusive of GST.
- Quoted rates should have validity period of at least 30 (thirty) days from the date of opening of quotation.
- Supply of the material shall be completed within 5 days from the date of issue of supply order with the satisfaction of competent authority.
- The period of subscription will be 1 year which may be extended further on mutual agreement of bidder and buyer.
- Bidder, who fails to provide services as per specifications / terms and conditions after quoting rates, is likely to be recommended for black listing.


