- 1) The services of the wooden country boat will be in the river Kaljani at Ambari.
- 2) The rates are to be quoted both in words and figure against each item. The rates shall be inclusive of all
- 3) The wooden country boating services shall be commenced within 03 days on receipt of the order for the
- 4) The boat shall be well equipped with all accessories and appliances as per rules and safety provisions are to be made in the boat against any accident etc. by the supplier at his own initiative and cost. Capacity of boat would be to carry 8(eight) personnel at a time while taking hydrological observation.

- 10) Responsibility of safety and securities of boatman during hydrological observation in water i.e. in the river will entirely rest with the suppliers.
