

## NOTICE INVITING QUOTATION

Sealed quotations in prescribed pro-forma is hereby invited by the Sub-Divisional Engineer, TRS Sub-Division, Central Water Commission, Cooch Behar, PIN-736101 on behalf of the President of India from reputed firm/suppliers for hiring of wooden country boating service for the hydrological observation at Baladoba GDQ Site, Dhubri, Assam under TRS Sub-Division for the period from 01.07.19 to 31.10.19 on or before **28.06.19** at **1500 Hrs.** on the terms & condition and schedule noted below. The quotations will be opened on the **same day at 1530 hrs.** in presence of the suppliers or their authorized representative.

The terms and conditions of the NIQ are mentioned below:-

### Terms and condition

- 1) The services of the Power driven wooden country boat will be in the river Sankosh at Baladoba.
- 2) The rates are to be quoted both in words and figure against each item. The rates shall be inclusive of all charges.
- 3) The wooden country boating services shall be commenced within 03 days on receipt of the order for the urgency of works.
- 4) The Capacity of the Engine for driving the boat should not be less than 15 HP & the engine should not be more than 5 years old.
- 5) The boat shall be well equipped with all accessories and appliances as per rules and safety provisions are to be made in the boat against any accident etc. by the supplier at his own initiative and cost. Capacity of boat would be to carry 8(eight) personnel at a time while taking hydrological observation.
- 6) Maintenance and repair of the boat shall have to be made by the supplier at his own initiative and cost to the satisfaction of the Department.
- 7) The actual site of operation of boat services will be shown by the Engineer in Charge or his authorized representative.
- 8) The boat with boatman will be deployed on "No work no pay" basis. Therefore the department will not entertain any claim of idle period, if any.
- 9) Fuel will be supplied by the department.
- 10) The boat with boatman on hire charges basis shall normally be engaged by the department for taking hydrological observation once in everyday (excluding Sunday and holidays) and period of the engagement shall be reckoned on the basis of actual engagement in the work.
- 11) Claim/ claims for damages or loss of boat and life due to accident or otherwise either natural calamity or other reasons whatsoever shall not be entertained by the department.

- 12) Responsibility of safety and securities of boatman during hydrological observation in water i.e. in the river will entirely rest with the suppliers. Necessary compensation in case of any accident will have to be paid by the supplier as per rule. CWC will not be held responsible for any such unforeseen events and no compensation shall be paid by the CWC Department.
- 13) Payment will be made after submission of pre receipted bills in triplicate by the supplier. No advance payment is admissible.
- 14) The undersigned reserves the right to reject any part or whole of the quotation & without assigning any reason whatsoever otherwise the amount will be deducted from the monthly bill.
- 15) Successful quotationer will have to deposit @ 10% of the total value of work order exceeding Rs.1000/- as security deposit.
- 16) Tendered Offer Shall remained open for acceptance by the department for the period of 90 days from the date of opening of quotation.
- 17) The quoted rate should also include 1% labour welfare cess and 18% GST to be deducted by CWC from the bill for making payment to the respective concerned Departments.
- 18) The tax deduction at source (T.D.S.) shall be deducted as per provisions of income tax department as amended from time to time and a certificate to this effect shall be provided to the agency by this office.
- 19) Copy of PAN / Voter card and GST registration No. should be submitted.
