NOTICE INVITING QUOTATION


For and on behalf of the President of India, sealed quotations are invited for the following work by the undersigned from the authorized / reputed contractor/firms for carrying out the "Repairing work of Junior Engineer office /transit camp at Tlawng H.E. The Sealed Quotation will be received in the office of undersigned i.e. O/o Executive Engineer, NEID-II, CWC, Aizawl during working hours upto 15:30 hrs. on or before 16/02/2019 & shall be opened on same day by 16:00 hrs. by the undersigned/authorized official in presence of interested quotationers or their authorizes representatives who desired to remain present at the time of opening of quotations.

Terms and Conditions :-

1. The work should be completed as per specification within 15 (Fifteen) days from the date of issue of work order.
2. The bidder shall submit EMD (Earnest Money Deposit) of Rs. 2350/- (Rs. Two thousand three hundred and fifty only), along with the quotation in the form of Demand Draft/ Treasury Challan/ Call Deposit/ Banker's Cheque/ Fixed Deposit receipt drawn on the Scheduled Nationalized Bank in favour of Executive Engineer, NEID-II, CWC, Aizawl, payable at SBI, Aizawl.
3. The work should be standard quality and free from all defects and if found not suitable the same shall be asked for replacement at his own cost.
4. The rates shall be kept valid for minimum period of 60 days from the date of opening of quotation.
5. The rates are to be quoted F.O.R. destination inclusive of packing forwarding, freight, insurance, if any, at the Junior Engineer office/ transit camp at Tlawng H.E. Project site near lungleng village, Dist Aizawl.
6. The rates should be inclusive of all local taxes such as Service Tax/GST etc.
7. Rates of Service tax/GST should be mentioned as applicable.

8. The rate of works should be quoted both in figures as well as in words.
9. The quotation number with date of its opening has to be clearly mentioned on the top of the quotation and sealed cover.
10. The quantities mentioned are likely to increase or decrease at the time of placing of supply/work order.
11. Any correction in the quotation should be clearly attested.
12. Request for any advance payment will not be entertained.
13. All taxes applicable as per rule will be deducted from the final bill.
14. The work carried out by the firm shall be guaranteed for a period of not less than six months from the date of completion of work.
15. The undersigned reserves the right to cancel/reject in part or full or any/all the quotation without assigning any reason thereof and without any financial involvement from either side.
16. Payment will generally be made through RTGS/NEFT directly on the bank account of the bidder on production of bills.
17. Name & address of A/c payee to whom tax deducted at source may be paid shall be mentioned alongwith the bill.
18. Only those firms having PAN/TIN/GST clearance certificate etc. can be eligible to submit their quotation.
19. Any quotation, which does not comply with the above guidelines, runs the risk of being rejected.
20. In case of any dispute, the decision of The Executive Engineer, NEID-II, CWC, Aizawl shall be final and binding on all concerned.

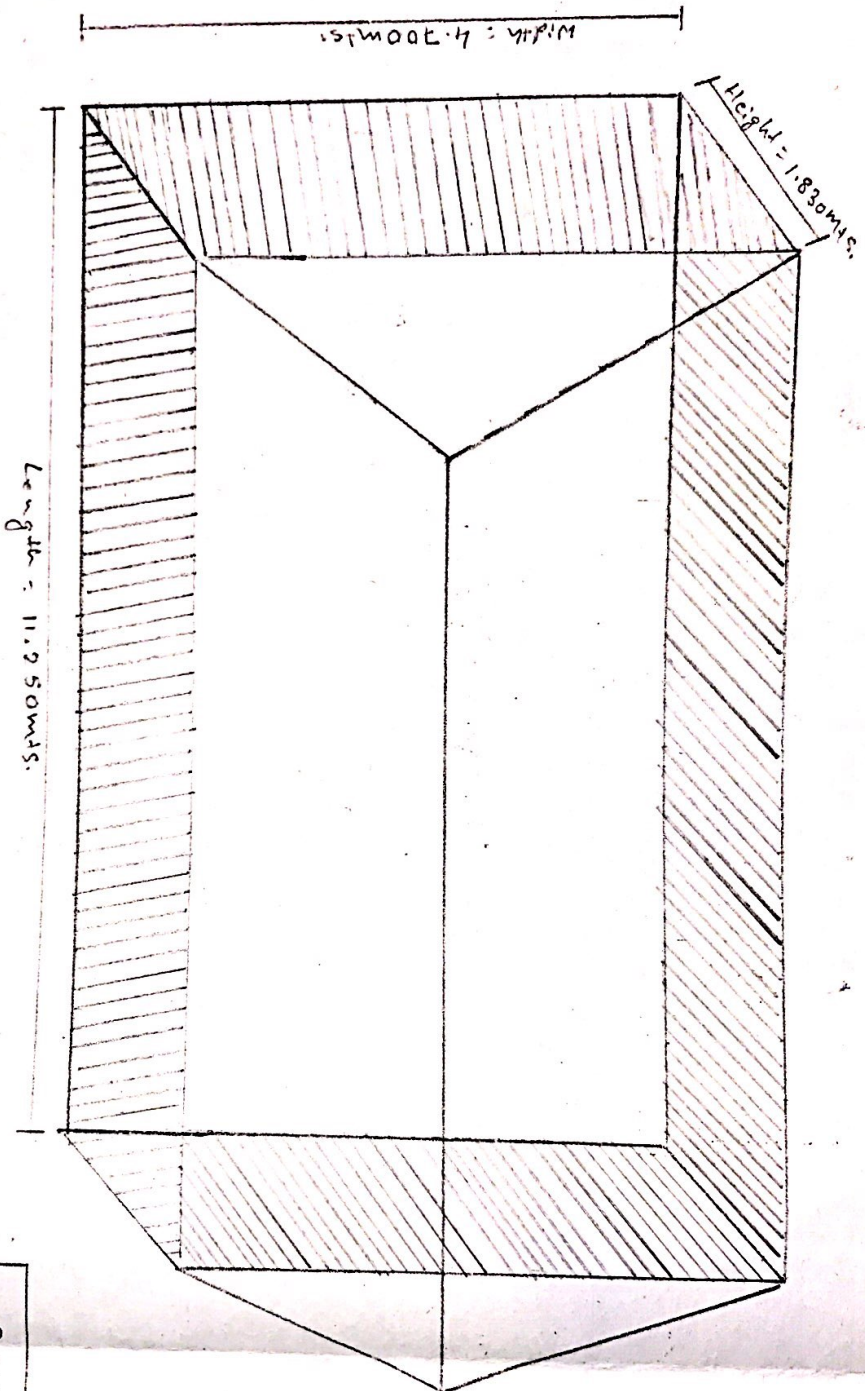
