The quotation will be received in the office of the undersigned i.e.O/o Executive Engineer, NEID-I, CWC, Rongpur Part-I, Silchar-9 during the working hours up to 15.30 hrs on or before 06/11/2020 and shall be opened on the same day at 16.00 hrs by the undersigned/authorized officials in presence of the interested quotationers or their authorized representatives who desire to remain present at the time of opening of quotations.

Terms and Conditions:-

- 1. The works should be completed as per specification within 10 (Ten) days from the date of issue of the work order.
- 2. The bidder shall submit EMD (Earnest money deposit) of Rs. 2644/- (Rupees Two Thousand Six Hundred and Forty Four only), along with the quotation in the form of Demand Draft/ Treasury challan/call Deposit/ Banker's cheque/ Fixed Deposit receipt drawn on a Scheduled Nationalized Bank in favour of <u>Executive Engineer</u>, <u>NEID-I</u>, <u>CWC Silchar</u>, <u>payable at SBI</u>, <u>Silchar</u>. Quotations received without EMD will be rejected
- 3. The work should be standard quality and free from all defects and if found not suitable the same shall be asked for replacement at his own cost.
- 4. The rates shall be kept valid for minimum period of 60 days from the date of opening of quotation.
- 5. The rates are to be quoted F.O.R. destination inclusive of packing forwarding, freight, insurance, if any, at the office of the Executive Engineer, NEID-I, CWC, Rongpur Part-I, Silchar.

- 6. The rates should be inclusive of all local taxes such as Service Tax etc but excluding GST which shall be reimbursed to the contractor after production of receipts/challan/valid certificate.
- 7. Rates of GST should be mentioned as applicable.
- 8. The rate of works should be quoted both in figures as well as in words.
- 9. The quotation number with date of its opening has to be clearly mentioned on the top of the quotation and sealed cover.
- 10. Quotation may be dropped in the Tender/Quotation box kept in the office of the undersigned or may be sent by the registered post. (Marked as quotation for 'Repair and maintenance of boundary wall (painting works) at office cum residential colony complex at the NEID-I, CWC, Rongpur, Silchar.) to the undersigned so as to reach on or before the date and time stipulated for receiving the quotation. No quotation will be entertained after the stipulated time.
- 11. The quantities mentioned are likely to increase or decrease at the time of placing of work order.
- 12. Any correction in the quotation should be clearly attested.
- 13. Request for any advance payment will not be entertained.
- 14. All taxes applicable as per rule will be deducted from the final bill.
- 15. The work carried out by the firm shall be guaranteed for a period of not less than six months from the date of completion of work.
- 16. The undersigned reserves the right to cancel/reject in part or full or any/all the quotation without assigning any reason thereof and without any financial involvement from either side.
- 17. Payment will generally be made through RTGS on production of bills as per actual.
- 18. Name & address of A/c payee to whom tax deducted at source may be paid shall be mentioned along with the bill.
- 19. Only those firms having PAN, GSTIN clearance certificate, government registration etc. can be eligible to submit their quotation.
- 20. Any quotation, which does not comply with the above guidelines, runs the risk of being rejected.
- 21. In case of any dispute, the decision of the Executive Engineer, NEID-I, CWC, Silchar-9 shall be final and binding on all concerned.
