2. The spare parts and consumables for the DG set will be supplied by this office as per the requirement which should be intimated well in advance for keeping the DG set in working condition.
3. **The rate should be quoted both in figures and words inclusive of all taxes.** The GST as per Government rule in force from time to time shall be paid extra. All corrections should be signed by the authorized person. No overwriting is allowed.
4. No extra payment will be made if it is not mentioned in the quotation.
5. The rates should be valid for a period of 60 days from the date of opening of the quotation.
6. The complaint must be attended within 24 hours from the time of complaint or else penalty of Rs 200/-per portion/full day of delay beyond the 24 hours grace period shall be imposed.
7. If the agency is to carry the machine to their service centre and to be retained beyond 48 hours, alternative machine of equal or higher configuration must be arranged or else AMC charges proportionally shall be deducted for each day of delay.
8. The payment will be made on quarterly basis on receipt of bill through e-payment mode. Tax will be deducted as per rule. No advance payment shall be made on any account.
