- Interested bidders may submit their highest price for the vehicle in prescribed proforma (Annexure-II) of quotation document in a sealed cover clearly superscribing as "Quotation for disposal of old condemned Ambassador car (Petrol) No.GJ-1G -3227" to be opened on 28/07/2017 at 3.30PM by the Executive Engineer, Mahi Division, CWC, Gandhinagar. Unsealed and unsigned quotations shall be summarily rejected.
- 2. The sealed quotations should reach this office latest by 3.00 PM on 28/07/2017. The same will be opened on same date at 3.30 PM. Quotation should be dropped in the Tender Box kept inside the Chamber of the Executive Engineer, Mahi Division, CWC, Gandhinagar. The bidder or their authorised representative (not more than one) may witness the quotation opening, at the time of opening the quotations.
- 3. The car has been kept in the premises of Narmada Tapi Bhawan, Central Water Commission, Sector-10A, Gandhinagar (Gujarat). The intended bidders may inspect the vehicle on any working days between 3.00 PM to 4.00 PM from 17/07/2017 to 27/07/2017 (Telephone No. 079-23239509).
- 4. The disposal of vehicle shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality shall be given by this office.
- 5. Earnest money deposit (EMD of Rs. 5000/- (Rupees five thousand only in the form of Demand Draft/ Banker's cheque in favour of Executive Engineer, Mahi Division, CWC, Gandhinagar payable at Gandhinagar shall be accompanied with quotations, without which the quotation will be summarily rejected.
- 6. The successful bidder accepted by the competent authority has to pay the bid amount by Banker's cheque/Demand draft in favour of the Executive Engineer, Mahi Division, CWC, Gandhinagar payable at Gandhinagar with in 7 (seven) days from the date of communication about the acceptance of the quotation, failing which the EMD shall be forfeited.
- 7. The bidder should not be an employee of CWC and should not have any relative working in CWC. The bidder shall be required to indicate that they do not have any relative employed in CWC.
- 8. The EMD of the unsuccessful bidder shall be refunded within 7 days from the acceptance of quotation.
- 9. All, writings /quotes should be clear and legible and cuttings/corrections if any, in the quotation should be attested by the bidder, otherwise it will be make them liable to disqualification and rejection.
- 10. Taxes as applicable at the time of delivery will have to be paid by extra on the total amount quoted by the successful bidder.
- 11. The vehicle should be removed from the office premises by the successful bidder or his representative, duly authorised by the bidder in writing on his behalf. As far as possible, the vehicle must be removed from the office premises within 10 days from the date of depositing

- the total amount of bid and taxes as applicable, failing which the vehicle will be disposed off without any notice at the cost of successful bidder.
- 12. It shall be sole responsibility of the successful bidder to get the vehicle transferred in his/her name from the Road transport Authority and fulfil any other formalities with transport authorities for towage/disposal/removal of the vehicle from the WC premises, Gandhinagar.
