Terms and conditions:

- 1. The work should be completed strictly as per specifications and directions of Engineers in charge within 15 days from the date of issue of worker order.
- The bidder shall submit EMD (Earnest Money Deposit) of Rs 3960/-(Rupees three thousand nine hundred sixty) only along with quotation in the form of DD/Treasure Challan / call Deposit / Banker's cheque / fixed deposit receipt drawn on the Scheduled nationalised bank in favour of EE, NEID-II, CWC Aizawl, payable at SBI Aizawl.
- 3. The work should be of standard quality and free from all defect and if found not suitable the same shall be asked for replacement at his own cost.
- 4. The rates shall be kept valid for minimum period of 60 days from the date of opening of quotation.
- 5. The rates are to be quoted F.O.R. destination inclusive of packing forwarding, freight, insurance, if any, at the Executive Engineer, NEID-II, CWC, Aizawl.
- 6. The rates should be inclusive of all local taxes, such as service tax/GST etc.
- The rates of Service Tax /GST should be mentioned as applicable.
- The rate of works should be quoted both in figure and words.
- 9. The quotation number with date of its opening has to be clearly mentioned on the top of the quotation and sealed cover.
- 10. The quantities mentioned are likely to be increase / decrease at the time of placing of supply /work order.
- Any correction in the quotation should be clearly attested.
- Request for any advance payment will not be entertained.

- 13. All taxes applicable as per rule will be deducted from the final bill.
- 14. The work carried out by the firm shall be guarded for a period of not less than six months from the date of completion of work.
