

Terms and Conditions

1. The late bids i.e. the bids received after the specified date and time for receipt of bids shall not be considered.
2. The sealed quotation should super scribed as **"Repair and other works of vehicle No.KL 07X 5378 (Tata Sumo) of SWRD, CWC, Kochi "** and should be addressed to the Executive Engineer, South Western Rivers Division, CWC, Jaladhara, Kadavanthra, P.O.,Kochi-682020.
3. The quotation should reach this office on or before 10:00 hrs on 29/07/2019.
4. Rates shall be quoted "Per Unit" basis and shall include all charge related to transportation of material.
5. GST/Taxes, if any, shall be quoted separately failing which the quoted rates would be taken as inclusive of taxes and no subsequent request for addition of taxes would be entertained by this office.
6. If there is a discrepancy between unit cost and total cost then unit cost will prevail. If there is a difference between words and figures the amount in words will prevail.
7. Discounts, if any, should be indicated in the quotation.
8. Offers may be submitted on firm price basis
9. Rates should be valid for at least 90 days from the date of opening of quotation
10. The work shall be as per specification & terms and conditions as mentioned.
11. The quantity indicated is tentative only and is likely to vary. The payment shall be made as per actual measurement done.
12. Payment will be made by e-payment after the successful completion of supply to your concerned bank account, for which Mandate form from the bank may please be provided along with the bill.

13. Quotationer shall be fully responsible on the entire stores contracted for arrival in good condition at F.O.R destination.
14. The work must be completed as per the specification within 12 days of issue of work order from this office.
15. The materials/work not conforming to the specifications stipulated above or defective material and substandard works are liable to be rejected and any loss or damage occurred during transit or rejection of works will have to be borne by the firm itself.
