

Terms & Conditions -

1. The quotations shall reach to this office on or before 15-02-2019 up to 14:00 Hrs. which will be opened on the same day at 14:30 Hrs. in presence of the quotationers who desires to witness the opening of quotations. The sealed envelope should be superscribed "**Quotation for Transportation of T&P items from Chambal Division, Jaipur to different sites under Chambal Division, CWC, Jaipur**"
2. Work shall be completed as per instructions of Executive Engineer, Chambal Division, CWC, Jaipur and **No advance payment will be made to quotationer.**
3. Quotationers must have permission to transport itmes from one state to another state and only commercial vehicle (**Mahindra Pick up or equivalent**) shall be provided for this work.
4. **Payment towards Toll tax, other state tax like PT (Permission Tax), GST etc. will be made as per actual on submission of original receipts in this regard.**
5. Rates shall be quoted both in figure as well as words also.
6. Rates quoted should be valid at least for 90 days from the date of opening.
7. The quotationers will be completely responsible for its vehicle and driver etc., in case of any misshapen/accident, etc.
8. Maintenance, if any required during entire journey shall be borne by quotationer himself.
9. **Loading & boarding for driver shall be arranged by quotationer himself.**
