

OFFICE ORDER


Consequent upon her promotion to the grade of Sr.PPS of CSSS cadre, on "ad hoc basis" vide Ministry of Home Affairs OM No. A-32014/02/2018-Ad.I(A) dated 31.12.2018 (copy enclosed) & National Disaster Management Authority's Order No.A-13/42/2010-Admn dated 07.01.2019, in Level-12, w.e.f. 31.12.2018 & subsequently her promotion on "regular basis" on her inclusion in the Select List Year 2017(SQ) as Sr.PPS vide Department of Water Resources, RD & GR's Office Order No. 22/2019 (through File No.A.32013/5/2018-Admn) dated 13.06.2019 and in pursuance of DoPT OM No.2/3/2018-CS.II(A) dated 30.04.2019 the pay of Smt. Nirmala Kumar, Sr. PPS is re-fixed in the corresponding scale of pay of Rs. 78,800-2,09,200/- in the Level -12 w.e.f. 01.07.2019(F.N) as per option exercised & revised by the Officer (as per Department of Expenditure OM No.4-21/2017-IC/E.IIIA dated 28.11.2019) is as under:-
