NOTICE INVITING TENDER

The Executive Engineer, Damodar Division, CWC, Asansol, invites, on behalf of President of India, item rate e-tenders comprising of technical and financial bids from Original Equipment Manufacturers (OEM)/ Authorised dealers for the Procurement of Bridge outfit and Meteorological equipments.

- 1.1 The supply of goods is estimated to cost Rs.3, 49,280.00. This estimate, however, is given merely as a rough guide.
- 1.2 Intending Tenderer is eligible to submit the tender, provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar supplies.
- 1.3 Similar works means successful supply, testing & demonstration of Bridge outfit and D.O.Sampler to any Central/State or Public sector unit during last 5 years.
- 2. **Eligibility Criteria:** Tender shall be issued only to eligible firm who fulfils following qualifying requirements:
- 2.1 They should have a Valid PAN No. /VAT No. (Copy to be enclosed).
- 2.2 They should have a Valid Service Tax Registration No.
- 2.3 They should have valid Sales Tax Registration No
- 2.4 The Firm should have a minimum experience of five years in the field of supply, testing & demonstration of Bridge outfit and D.O.Sampler to Government / public Sector undertaking
- 3. The location of supply is given at Page No. of this Tender Document.
- 4. Tender Document is available on through the CPPP website https://etenders.gov.in, Central Public Procurement (CPP) Portal URL www.eprocure.gov.in and CWC website URL www.cwc.gov.in. The bids shall be submitted online at upto 16.00 Hrs. of 18/02/2021.
- 5. Agreement shall be drawn with the successful tenderer on prescribed Form No. CPWD7/8, which is available as a Govt. of India Publication. Tenderer shall quote their rates as per various terms and conditions of the said form which will form part of the agreement.
- 6. The time allowed for carried out the supply will be 30(Thirty) days.
- 7. The site for the supply is available.

- 8. The bidder has to give Bid Securing Declaration as per format specified in Annexure- D shall be scanned and uploaded to the e-Tendering website within the period of bid submission and original should be deposited in office of the Executive Engineer, Damodar Division, Central Water Commission, Asansol.
 - Copy of OEM certificate, OEM authorization certificate, certificate of previous successful completion of similar supply and other documents shall be scanned and uploaded to the e-Tendering website within the period of bid submission.

The submitted tender shall become invalid if:

- (i) The bidder is found ineligible.
- (ii) The bidder does not upload all the documents (including service tax registration /VAT registration/Sales Tax registration) as stipulated in the bid document.
- (iii) If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically in the office of tender opening authority.
- 9. The tenderer whose tender is accepted will be required to furnish Performance guarantee of 3% (Three Percent) of the bid amount within the period specified in Schedule 'F'. This guarantee shall be in the form Demand Draft of any scheduled bank/ Securities or Fixed Deposit Receipts or Guarantee Bonds of any scheduled bank or the State Bank of India in accordance with the prescribed form.
- 10. Intending Tenderers are advised to inspect and examine the site and its surrounding and satisfy themselves before submitting the tenders. They may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. Submission of tender by a tenderer implies that he has read this notice and all other contract documents and made himself aware of the scope and specifications of the supply to be done.
- 11. The competent authority on behalf of the President of India does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.
- 12. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the bidders who resort to canvassing will be liable for rejection.
- 13. The competent authority on behalf of the President of India reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same ate rate quoted.
- 14. The tenderer shall not be permitted to tender for works in the CWC Circle responsible for award and execution of contracts, in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer of the concerned Circle, and Sub divisional Engineer / Junior Engineer (all inclusive). He

shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazetted officer in the Central Water Commission or in the Ministry of Water Resources, River Development & Ganga Rejuvenation (MoWR, RD & GR). Any breach of this condition by the tenderer would render his tender liable to be rejected.

- 15. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of one year after his retirement from Government service, without the previous permission of the Government of India in writing. This contract is liable to be cancelled, if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the tender or engagement in the contractor's service.
- 16. The tender for the supplies shall remain open for acceptance for a period of sixty (60) days from the date of opening of bids. If any tenderer withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to the department. Further the tenderer shall not be allowed to participate in the retendering process of the supply.
- 17. This notice inviting Bid shall form a part of the contract document. The successful bidder/firm, on acceptance of his bid by the Accepting Authority shall within 15 days from stipulated date of start of supply, sign the contract consisting of:-
 - (a) The Notice Inviting Bid, all the documents including additional conditions, specifications and drawings, if any, forming part of the bid as uploaded at the time of invitation of bid and the same the rates quoted online at the time of submission of bid and acceptance thereof together with any correspondence leading thereto.
