NOTICE INVITING TENDER (NIT)

On the behalf of the President of India, The Executive Engineer, Himalayan Ganga Division, Central Water Commission, Haridwar invites online Tenders on item rate basis from eligible contractors for the following work:

1. **Name of work** "Development of land at Mana site, Badrinath Chamoli under Himalayan Ganga Division, CWC, Haridwar (Uttarakhand)"
2. **Estimated Cost: ₹ 17,99,500/- (Seventeen Lakh Ninety Nine Thousand Five Hundred Only)**
3. **Period of Completion** : 90 Days from issue of letter of award of the work.
- Sale of Tender** : From 08.07.2024 (10:00 Hrs.)
- Online Submission of Bid** : From 09.07.2024 (11:00 Hrs.) to 01.08.2024 (15:00 Hrs.)
- Online Opening of Tender** : On 02.08.2024 (15:30 Hrs.)

4. Eligibility criteria:

- A. The Contractor should be registered with a valid registration certificate. Contractor should be registered with CPWD, MES, P.W.D, Railways, or other Government bodies/PSUs etc.
- B. The Contractor must have valid PAN and GST registration at the time of submission of bid.
- C. The Contractor must have executed work of similar nature in the last 3 years ending March 2024 as per the value of each work as detailed below:
 - a) **Three** similar completed works costing not less than the amount equal to 40% of the estimated cost.
 - or
 - b) **Two** similar completed works costing not less than the amount equal to 60% of the estimated cost.
 - or
 - c) **One** similar completed work costing not less than the amount equal to 80% of the estimated cost.

Similar works means civil works related to Repair/Masonry/ RCC Construction, Earthwork and Erection & Installation of Steel/Prefabricated Structures.

Completion certificates for the above should clearly indicate the scope and nature of work carried out and the value of various components of work as executed, in order to confirm conformity to defined similar works. The completion certificate should be signed by the issuing authority with stamp without which the works will not be considered.

5. **Average annual financial turnover of ₹ 17,99,500/- in the previous 3 financial years year also be submitted the successful bidder has to submit the same within 01 month of award of work to avoid rejection of bid.**
6. Tender can also be freely downloaded from central procurement portal (www.eprocure.gov.in), and from

Earnest money of **₹90000/- (Rupees Ninety Thousand Only)** in form of FDR/DD in favor of Executive Engineer, Himalayan Ganga Division, CWC, Haridwar must be submitted with the tender otherwise Tender will not be entertained.

7. Bids can be submitted only through online on Central Public Procurement Portal website (www.eprocure.gov.in), as detailed under ITB (Instructions to bidders).
8. The bids will be opened online at the date mentioned in **Tender Data Sheet**, in presence of the bidders who wish to see the online opening of tender or offline through their authorized representative who may choose to attend online opening in the office of Executive Engineer, Himalayan Ganga Division, Central Water Commission, Haridwar (Uttarakhand)-249403.
9. **Bids shall be accepted through e-procurement only at e-tendering platform of Central Public Procurement Portal (CPPP).**
10. Contractor should maintain the quality of work at site, the rates will not be accepted 10% above or below the estimated cost of tender.
