- 2. The Bidders should clearly indicate their GST & PAN Number (Signed copy attached).
- 3. The prices quoted shall be for office of the Executive Engineer, Lower Yamuna Division, CWC, 404-409, Sector 12-C, Avas Vikas Colony, Sikandra, Agra- 282007 and inclusive of all duties and taxes including freight charges, Custom Duty, Octroi, VAT, GST, Entry and Other taxes etc. and no additional amount on the quoted prices shall be paid on account of such duties, taxes and Octroi etc.
- 4. Duly filled and signed Eligibility Declarations as per Annexure-1 with requisite documents must be submitted with Quotation.
- 5. Quotations received without Eligibility Declarations will be rejected summarily.

- 10. Intimation of unsuccessful quotation will not be given to concerned Firms and the Bidders shall have no claim of any nature on this office.

- 11. Bill in duplicate should be submitted and payment will be released only after the satisfactory work done, through PFMS. Bank details/Mandate form must be submitted along with bill.
- 12. In case if the firm fails to complete the work as per terms and conditions then necessary action may be taken against the firm.
- 13. Any other rules of CPWD codes and its amendment as applicable will be binding on the successful bidder.
