4. The rates shall be quoted inclusive of all Tax, levies and EXCLUSIVE GST & valid for 30 days minimum from the date of opening of the quotation.
5. The work should be completed within 1 month from award of Supply order need to be quote their rates.
6. The above mentioned work shall be done in Staff quarter: B-2 and B-3, Block-8, Strawberry Hills, Shimla.
7. The payment will be made through PFMS after actual measurement of work on successful completion for which bill in triplicate shall be submitted to this office.
