## **NOTICE INVITING E-TENDERS**

1. The Executive Engineer, North Eastern Investigation Division-II, Central water Commission, Zemabawk, Aizawl (Mizoram) invites item rate tender on behalf of president of India, comprising of technical and financial bids under two bid system for the work "Location of Dam Axis power house and Drill hole marking at Mat-Sekawi HEP under NEID-II, CWC, Aizawl" form contractor/service provider who are registered under appropriate authorities of Government of India (Central/State).

- 3. The bidder has to submit following documents in hard copy in a sealed envelope in office before last date and time of opening of tender otherwise the bid will not be considered for opening:
  - i) Earnest Money Deposit in original payable at SBI, Aizawl
- **4.** Unless otherwise specified, in tender document, originals (or self-attested copies of originals as specified therein) of specified scanned uploaded documents must be physically submitted sealed in double cover and acknowledgement be obtained before the bid submission deadline at mentioned venue. Failure to do so is likely to result in the bid being rejected. If the office is closed on the deadline

- for physical submission of originals, it shall stand extended to the next working day at the same time and venue.
- **5.** The bids of the tender will be opened online at **12.00 hrs. on 25.01.2024** in presence of the tenders/bidders who wish to see online opening of tender or offline through their authorized representative who may choose to attend online opening in this office.

- **7.** Bids shall be accepted through e-procurement only at CPP portal of <a href="https://eprocure.gov.in/">https://eprocure.gov.in/</a> eprocure/app.
- **8.** The bidder should fulfill the following eligibility criteria:
  - a. The contractor should be registered with any one organization such as C.P.W.D, MES, BSNL, Railways and State P.W.D./State agencies/Autonomous bodies.
  - b. Average Annual financial turnover of related services during the last three financial years i.e. 2020-21, 2021-22, and 2022-23 should be at least 5 lakh (Five lakhs).
  - c. The firm should have completed at least three similar works each of value not less than 40% of Estimated cost put to tender (ECPT) or two similar work each of value not less than 60% of ECPT or one similar work of value not less than 80% & of ECPT in last 3 years ending previous day of last date of submission of bids.

### \*Similar works means construction of civil works

- d. The contractor should be registered with GST departments and have valid Certificate of GST and other certificate required as per law.
- e. The contractor should have a Valid PAN No.
- **9. Verification of Details:** Executive Engineer, North Eastern Investigation Division-II, CWC, Aizawl reserves the right to verify the particulars furnished by the Bidder independently. If any information furnished by the Bidder is found to be incorrect at a later stage, his / her performance guarantee shall be forfeited and he / she shall be debarred from tendering for the works of CWC in future.
- **10. Period of Contract:** The duration of the Contract shall be for a period of 60 days which can be revised or extended depending upon the exigency of work.
- 11. Availability of Work Place: The workplace is available
- **12.** Bidders are advised to follow the 'Special Instructions to the Contractors/Bidders for the e- submission of the bids online' available through the link 'help for Contractors' at the e- Procurement Portal https://eprocure.gov.in/eprocure/app.
- **13.** Bidder shall not modify the downloaded tender form including downloaded price bid template in any manner. In case any tender form/Price bid template is found to be tampered with/modified in any

manner, such bid will be summarily rejected, Bid Security would be forfeited, and bidder would be liable to be banned.

- **14.** Bidders are advised to check the website <a href="http://cwc.gov.in">http://cwc.gov.in</a> and CPPP website <a href="https://eprocure.gov.in/eprocure/app</a> at least 1 day prior to closing date of submission of tender for any corrigendum, addendum, or amendment to the tender document.
- 15. Visit to Work Place by Bidder: Bidder are encouraged to inspect and examine the work place and its surroundings and satisfy / apprise themselves as to the nature of the work, the means of access and in general, shall obtain themselves all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender and rates, before submitting their tenders. A bidder shall be deemed to have full knowledge of the work place whether he/ she inspects the site or not and no extra payment / compensation consequent upon any misunderstanding / miss-happening or otherwise shall be allowed. The bidder shall be responsible for arranging and maintaining all materials, tools & plants, access, facilities for his personnel and all other services required for executing the work at his/ her own cost, unless it is specifically mentioned in the contract documents.
- **16.** Tenders, in which the prescribed conditions are not fulfilled or are incomplete in any respect, are liable to be rejected.
- **17.** The competent authority on behalf of President of India does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reasons.
- **18.** All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.
- **19.** Canvassing whether directly/ indirectly, in connection with tender is strictly prohibited and the tender submitted by a Bidder who resorts to canvassing is liable to rejection.
- **20.** The competent authority on behalf of President of India reserves to him/herself the right of accepting the whole or any part of the bid and the bidders shall bound to perform the same at the rate quoted.
- 21. The bidder shall not be permitted to tender for works in this division office responsible for award and execution of contracts, in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any Gazetted officer in the Central Water Commission or in the Ministry of Water Resources, Ganga Rejuvenation & River Development, Govt. of India. Any breach of this condition by the contractor would render his/her bid to be summarily rejected.
- 22. Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is not allowed to work as a contractor for a period of one year after his/her retirement from Government service, without the prior permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the bid or engagement in the contractor's Service.
- 23. Signing of Contract Agreement: The Successful bidder/ contractor, on acceptance of his bid by the accepting authority shall within 15 days from the stipulated date of start of the work, sign the contract

# agreement consisting of:

- a. The Notice inviting tender, all documents including terms & conditions, any corrigendum to this tender (if issued by the O/o Executive Engineer, North Eastern Investigation Division-II, CWC, Aizawl) shall form part of the tender as issued at the time of invitation and rates quoted at the time of submission of tender and acceptance thereof together with any correspondence leading thereto.
