Kind reference is invited to the trailing email vide which it is to inform that TCIL has discontinued its ETS Tendering Portal w.e.f. 15 May 2019. No any new tender can be initiated after 15 May 2019 on ETS Portal of TCIL. However, ongoing tenders which was uploaded before 15.5.2019 can be processed till 30 June 2019 as informed by TCIL Officials.

This office has already pursuing the case of subscribing CPP Portal of NIC with MoWR, RD & GR for performing electronic tendering activities at CWC which is at very advanced stage. All the activities are expected to be completed by third week of June 2019.

In view of above, in this intervening time of subscribing new e-procurement portal at CWC, the tendering process for the procurement under your organization can be completed through offline mode after taking due approval in line with GFR 2017.

It is also suggested that procurement can be explored / performed at GeM Portal as manpower services are already available on GeM.
