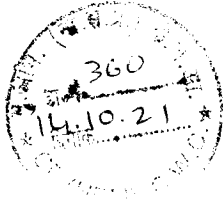

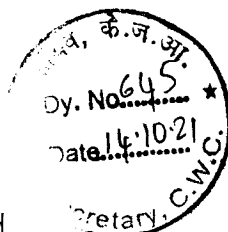

- (iii) possessing a bachelor's degree in Civil Engineering and five years of experience in planning / construction / design / maintenance, in Civil and Technical / Technical / Industrial structures / Estate Management and Contract Management from a recognised Institute.

**B. Executive Engineer (Mechanical / Electrical)**

Officers of the Central Government:-

- (i) holding analogous post on regular basis in the parent cadre or department; **or**
- (ii) with five years of regular service in the post in Level-10 of the pay matrix; **and**
- (ii) possessing a Bachelor's degree in Mechanical / Electrical Engineering and five years of experience in planning / construction / design / maintenance, in Civil and Technical / Technical / Industrial structures / Estate Management and Contract Management from a recognized Institute.

**Note-1:** The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment on promotion.

**Note-2:** The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same of some other organization/department of the Central Government shall ordinarily not exceed four years.

**Note-3:** The maximum age limit for appointment on deputation shall be not exceeding fifty-six years as on the closing date of the receipt of the application.

**Note-4:** Field experience of minimum three years in execution / project management of major project at site.




