The undersigned is directed to forward herewith copy of Department of Empowerment of Persons with Dissabilities's OM No. 38-03/2021-DD-III dated 01.02.2023, received through DoWR, RD&GR on the above mentioned subject.

2. It has been stated that as per note 4 of DEPwD's notification dated 04.01.2021, if a post is identified in the feeder grade, all the posts in the promotional grade should also stand identified. 
