 - c. To work out curriculum and identify certification requirements for the WUE Auditors
 - d. To suggest other aspects like the institutional frame work for achieving the objectives of the Bureau, Data compilation on water use efficiency on Annual Basis etc.
 - e. Task force shall provide the Framework Document in 3 months.
