1(20) The Padma Awards, namely, Padma Vibhushan, Padma Bhushan and Padma Shri, are amongst the highest civilian awards of the country. Instituted in 1954, these awards are announced on the occasion of the Republic Day every year. The award seeks to recognize 'work of distinction' and is given for distinguished and exceptional achievements/service in all fields/disciplines, such as, Art, Literature and Education, Sports, Medicine, Social Work, Science and Engineering, Public Affairs, Civil Service, Trade and Industry etc. All persons without distinction of race, occupation, position or sex are eligible for these Awards. A copy of the statutes and rules relating to these awards is enclosed (Annex - I).

It is the conventional practice to invite nominations for these awards from all Ministries / Departments of the Government of India as also from several other sources to enable broad-based consideration.

3. It has been decided with approval of competent authority that from this year the nominations/recommendations for the Padma Awards will be received online only on an electronic management system designed by MHA. (address of the website: www.padmaawards.gov.in.) The nominations/recommendations should contain all relevant details specified in the format available on the above said website, including a citation in narrative form (maximum 800 words), clearly bringing out the distinguished and exceptional achievements/service of the person recommended in his/ her respective field/discipline. While recommending a person online, please make sure that all the necessary details are filled properly. Details relating to the steps to be taken for making online recommendations are enclosed for guidance.

It has been observed in the past that while nominations are received in respect 4. of a large number of persons, there could, however, be several talented persons who are left out of consideration despite exceptional contribution in their field. Often many of these persons may get overlooked primarily for the reason that they may not seek publicity or attention in the public domain. It is, therefore, requested you to make concerted efforts in identifying such persons whose excellence and achievements really deserve to be recognized, and make suitable nominations in their. favour. It goes without saying that recognition of such deserving persons will only add to the lustre of these awards.

- 5. In the above background, I request you to kindly send suitable nominations for the Padma awards to be announced on the occasion of Republic Day, 2017. While finalizing the recommendations, the following points may be kept in view:-
 - (i) Persons recommended are pre-eminently worthy of the awards, looking at their life-time achievement. The criteria for selection should invariably be 'excellence plus' and the highest standards should be applied while recommending persons for these awards. The existence of an element of public service in the achievements of the person recommended for the award would be a desirable factor.
 - (ii) As the Padma award is the second highest award of the country, it should be considered whether the recommended person has earlier been given any National award or at least a State award in his respective field.
 - (iii) Efforts may be made to identify talented persons from amongst women, weaker sections of the society, SCs & STs, handicapped persons, etc., who deserve to be considered for the award.
 - (iv) The decoration is normally not conferred posthumously. However, in highly deserving cases, Government could consider giving an award posthumously if the demise of the person proposed to be honoured has been recent, say within a period of one year preceding the Republic Day on which it is proposed to announce the award.
 - (v) A higher category of Padma award can be considered in respect of a person who has earlier been conferred an award, provided a period of at least five years has elapsed. However, in exceptionally deserving cases, a relaxation can be considered.
 - (vi) Government servants including those working with PSUs, except Doctors and Scientists, are not eligible for Padma Awards.
- The online nominations/recommendations for the Padma Awards will begin 6. from May 1, 2016 and the last date for nominations for Padma Awards is September 15, 2016. The cnt-off date may please be strictly adhered to, nominations/recommendations received only during 1st May, 2016 to 15th September. 2016 will considered. Ĭŧ may noted also he nominations/recommendations received through online mode only will be considered.

- The decoration shall be conferred by the President by a Sanad under his hand and seal.
- 2. The decoration shall be mainly circular in design, with a geometrical pattern superimposed on the circle (as in the representative drawing in the annexure). The diameter of the circular portion of the decoration shall be one and three-fourth inches and the thickness of the decoration shall be oneeighth of an inch. The geometrical pattern shall be composed of the outer lines of a square of me and three-sixteenths inches side, centrally placed on each side of which shall be a rectangle projecting beyond the rim thereby breaking the circumference of the circular design of the decoration. A knob shall be embossed within each of the outer angles of the geometrical pattern. There shall be a raised circular space of diameter one and one-sixteenth inches forming the centre-piece of the decoration. On the obverse a lotus flower shall be embossed in this circular space. The name of the decoration shall be embossed in Hindi, with the word PADMA placed above and the word VIBHUSHAN placed below the lotus flower. On the reverse shall be embossed the State Emblem and morto in Hindi below it. The decoration shall be of toned brouze. @The inscription PADMA VIBITUSHAN on the obverse of the decoration, the geometrical pattern on either side and the border around the periphery, shall be of burnished bronze. All embossing on either side of the decoration shalf be of white gold.
- 3. A scaled pattern of the decoration (manufactured according to the specifications described above and the drawing in the annexure to these regulations) shall be deposited and kept.





- 5. The Central Ministry/Department/State Government/UT Administration may also forward names of eminent individuals/institutions/employees/employers, who in their opinion have contributed to the empowerment of persons with disabilities, but have not applied for the award themselves.
- 6. The applications of those employed/associated with the Central/State Governments/Union Territory Administrations/Public Sector Undertakings should be forwarded through the Ministry/Department/State Government/Union Territory Administration/Public Sector Undertaking concerned. In case of others (including self-employed persons and those in private sector organizations/unorganized sector), applications should be routed through and recommended by one of the following:-
 - > Department of the concerned State Government/Union Territory Administration, dealing with disability matters.
 - > Central Ministry/Department dealing with the relevant subject or area.
 - > A National Institute dealing with rehabilitation of Persons with Disabilities.
 - > Collector of the District where the applicant individual/institution is located.
 - A past recipient of a National Award for Empowerment of Persons with Disabilities.

Incomplete applications or applications received after due date and/or not recommended by the competent authorities will not be entertained without any further reference in the matter.

7. Applications/nominations will be initially short-listed and selection of recipients of awards will be made by various Screening Committees and a National Selection Committee respectively. Selected recipients of awards will be reimbursed up to 1st Class or AC-II Tier to and fro train fare from their place of residence for receiving the award in New Delhi. Respected Sushri Uma Bharti ji,

I would like to mention that the Ministry of Youth Affairs and Sports had introduced a new Central Sector Scheme, namely, 'National Young Leaders Programme (NYLP)' with a view to develop leadership qualities among the youth. One of the components of the Scheme is National Young Leaders Awards (NYLA). A copy of the Scheme Guidelines relating to NYLA is enclosed for your kind perusal.

- It may be seen that the objective of introducing National Young Leaders Awards is to motivate the youth to strive for excellence in their respective fields by recognizing and rewarding the outstanding work done by them. The Awards are proposed to be conferred in about 50 sectors/ domain areas. A list of 34 such sectors/domain areas is given in Annexure-I to the enclosed Scheme Guidelines. The Ministries/ Departments could suggest more domains/ sectors. In each sector/ domain area, two Awards shall be conferred - one for a young man and another for a young woman.
- Since the domain expertise for various sectors is with respective Ministries/ Departments, it has been stipulated in the Scheme that the concerned Ministries/ Departments shall make selections of Awardees in respect of their sectors. Most of the Ministries/ Departments already have Schemes for conferring awards for outstanding work in their respective sectors. The guidelines/ procedure followed for selecting awardees under such Scheme may be followed for NYLA as well, with the exceptions that under NYLA, the selected awardees shall be a youth in the agegroup of 15 - 29 years. The Selection Committees for NYLA may include a nominee from the Ministry of Youth Affairs and the names of selected Awardees should be approved at the level of Minister in the Ministry concerned.

National Young Leaders Awards (NYLA)

1. Objective:

The youth are doing pioneering work in all the sectors. The objective of this Programme is to motivate the youth to strive for excellence in their respective fields by recognising and rewarding the outstanding work done by them. Such exceptionally talented youth could serve as role models and mentors for others. The Department of Youth Affairs currently has programmes such as National Youth Awards, Indira Gandhi NSS Awards, etc. to reward outstanding work done by the youth, primarily in the field of community service. Other Ministries/ Departments also have schemes for rewarding outstanding work in their respective sectors, but the same are not specifically focused on youth. Hence, there is a need for an all-encompassing programme, covering all sectors, for rewarding outstanding work done by the youth. NYLA seeks to achieve that objective.

2. Sectors or Domain Areas to be covered:

The Youth are playing an importance role in almost all sectors. It is proposed to cover all important sectors/ domain areas under the Scheme. The Awards will be instituted in about 50 sectors/ domain areas. In each sector/ domain area, two Awards shall be conferred - one for a young man and another for a young woman. Thus, there will be total about 100 Awards. A suggestive list of such sectors/ domain areas is enclosed as Annexure-I. The List shall be finalised in consultation with various Ministries/ Departments.

3. Nature of the Award and Eligibility Conditions:

- 3.1 The Award shall comprise of (i) a Medal (ii) a Certificate of Honour and (ii) Cash Award of Rs.1,00,000/-.
- 3.2 In order to be eligible for the Award, a person should be a youth in the age-group of 15-29 years. In other words, the person should have completed 15 years of age on the 1st April of the financial year for which the award is to be conferred and should not be more than 29 years on the 31st of March of that financial year.
- 3.3 Since the requirements in respect of various sectors may vary, the concerned Ministry/ Department may stipulate additional conditions in respect of their sectors, as may be considered necessary and appropriate.



4. Procedure for Selection of Awardees and Presentation of the Award:

- 4.1 The names of the Awardees in various sectors/ domain areas shall be finalised by the concerned Ministries/ Departments.
- 4.2 Each Ministry/ Department shall lay down, in respect of their sector/ domain area, the parameters for evaluating performance, the prescribed proforma for submission of applications/ nominations, the procedure for selection, etc. The Selection Committee may preferably be headed by the Secretary of the Department. The Department of Youth Affairs shall have representation in the Committee.
- 4.3 The Annual Calendar of all activities connected with the Awards shall be laid down. All Ministries/ Departments shall follow the calendar, finalise the names of Awardees and the forward the same to the Department of Youth Affairs.
- 4.4 The Department of Youth Affairs shall make all necessary arrangements for the Awards Ceremony. The Awards Ceremony shall be organised on National Youth Day (12th January every year) or any other suitable day as may be decided. It is proposed that the Awards should preferably be conferred by Hon'ble President of India or Hon'ble Prime Minister of India, so that they get the importance that they deserve.

5. Pattern of Financial Assistance

The financial assistance under this component shall be provided for the Cash Award money @Rs 1,00,000 for each Award, the expenditure on preparation of Medals/ Certificates of Honour/ Citations, expenditure on TA/ DA, boarding and lodging of the Award winners and other expenses connected with organisation of the Awards Ceremony.

6. Expected Outcome:

The Programme shall motivate the youth to strive for excellence in their respective fields.

7. Implementing Agency:

The Programme shall be implemented by the Department of Youth Affairs.
