I am directed to say that it has been observed on many occasions that the Junior Engineers posted to sites in general and at the remote sites in particular are unwilling to join there due to one or other reasons like lack of facilities for children education/medical treatment/proper accommodation/sites located in a remote places, etc. Due to non-joining JEs at those places, the works at sites are suffering heavily. After careful examination, the following are the sites identified that are located in the remote places:

The above issue has been taken up with the higher authorities. It has been decided to frame internal policy/guidelines for rotational transfer/posting of JEs within KGBO who are willing to work at those remote sites. Accordingly, the following are the guidelines:

(i) JEs posted at remote locations, after completion of a minimum tenure of 3 (three) years (excluding leave period in excess of leave accrued during that period) shall be entitled to opt for three choice places under KGBO, which will have to be considered by CE(KGBO), as far as possible;

- The stay at choice place will be protected to the extent of period of posting at (ii) remote locality except otherwise where such transfer is necessitated due to promotion; and
- (iii) They will not be entitled for any other monetary benefits as in the case of officials posted at NER

The above guidelines will be implemented with effect from 01.02.2014.

Further, the above mentioned weightages do not applicable to the persons of the concerned State where the CWC's sites are located.

It is requested that this may be broght to the notice of all concerned Junior Engineers working under this organisation.
