Subject: Outside influence by government servants in service matters – regarding.

Sir.

I am directed to say that this Department has been receiving numerous VIP References/Representations requesting for transfer/posting of various officers/officials of Central Water Commission.

- 2. As per the existing instructions, wherever, in any matter connected with his service rights or conditions, a Government servant wishes to press a claim or to seek redressal of a grievance, the proper course for him is to address his immediate official superior, or Head of his office, or such other authority at the appropriate level who is competent to deal with the matter in the organisation.
- 3. Attention in this connection is invited to the provision of Rule 20 of CCS [Conduct] Rules, 1964 prohibiting Government servants from bringing outside influence in respect of service matter(s). Rule 20 of CCS (Conduct Rules), 1964 is paraphrased below:

"No Government servant shall bring or attempt to bring any political or other outside influence to bear upon any superior authority to further his interests in respect of matters pertaining to his service under the Government".

Moreover, representations by relatives of Government servant are also treated as outside influence, as clarified vide MHA O.M. No. F.25/21/63 — Estt(A) dated 19.09.1963.

4. In this regard, it is to state that such VIP References/Representations regarding service matters shall be viewed seriously and such acts may invite appropriate action including disciplinary action, as per extant rules in all such cases. You are, therefore, requested to bring these instructions to the notice of all employees working in Central Water Commission for strict compliance.
