Sir,

I am directed to say that the issue regarding pendency of pension cases of work-charged employees was reviewed in the meeting chaired by the Secretary, DoWR on 10.5.2023 wherein JS&FA and DCA were also present. During the meeting, it was pointed out that substantial number of pension cases of work-charged employees have been held up, interalia, on account of objections raised by the office of PAO(Pension) seeking approved consolidated list of work-charged employees and approval of competent authority thereon who were given temporary status in 1997 in pursuance of 1997 scheme of DoWR, RD & GR.

- 2. It was informed to the chair that as per standing orders, Superintendent Engineer/Director of the concerned Circle is Appointing Authority for appointment of work-charged staff in CWC. Hence, his authentication on service records of retiring work-charged staff should suffice and there may not be any requirement for the preparation of consolidated list of work-charged staff in a region.
- 3. Position stated in para 2 above was agreed upon and it was desired to provide a copy of the order declaring SE as Appointing Authority for WC staff to PAO(Pension) to facilitate settlement of pending pension cases.
- 4. Accordingly, a copy of the letter No.A-43012/02/2015-Estt.XII dated 27.9.2018 regarding declaration of Suptd. Engineer as Appointing Authority in case of Work-charged staff in field offices of Central Water Commission is enclosed for further necessary action.
