Consequent to acceptance of recommendations of the Limited Review Screening Committee, **Shri Rishi Srivastava**, then JAG Officer is granted 'Non-functional Upgradation' on **notional** basis in the Level-14 of the pay matrix (Rs. 1,44,200/- to 2,18,200/-) w.e.f. **01.04.2013** in compliance with the Hon'ble CAT order dated 30.10.2023 vide Department of Water Resources, RD & GR's Order No. A-32022/1/2024-E-I dated 09.10.2024.
