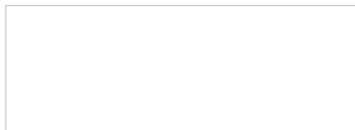
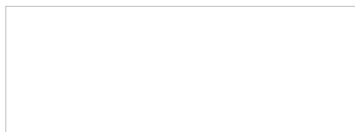

Sir,


PAO office is dealing pension/family pension cases of many casual workers of CWC who were given temporary status and subsequently regularised after 2004. They were covered under New Pension Scheme but now has been granted benefits of existing old pension scheme.

It has been observed by the undersigned that Head of Office/DDO are still submitting the pension/family pension cases of such employees without changing their status i.e. NPS to Old by NIC, Bhavishya. As a result, many cases are being returned by the PAO and pensioners/family pensioners are suffering unnecessary. It has also been seen that inspite of e-mailed and telephonic request to the concerned persons in the field office, many of them are resubmitting the cases without any action.

I, therefore, request you to ask all field offices to ensure that such cases have been converted by NIC, Bhavishya before submitting the same to PAO. For that purpose, field office will have to send a mail to NIC, Bhavishya alongwith following attachment:

- 1) Scanned copy of office order when employees was given temporary status
- 2) Scanned copy of office order when employees was given regular status
- 3) Copy of the PAN card of the employee
