

Minutes of the meeting held under the chairpersonship of Deputy Secretary (Admn) at 03:00 PM on 3rd July, 2024 to discuss the matter of delegation of financial power to Head of Department/Subordinate authorities in view of the extent limit of DFPR, 2024

A meeting was convened by Deputy Secretary (Admn) at 03:00 PM on 3rd July, 2024 in his chamber to discuss the matter of delegation of financial power (DFPR) to Head of Department/Subordinate authorities in view of the extant financial limits of DFPR, 2024

2. The meeting started with the brief introduction by Deputy Secretary (Finance) about existing delegation of financial powers to Head of Departments (HoDs) under the Department of Water Resources, River Development and Ganga Rejuvenation and Department (Sectt.) and the financial limits revised under DFPR, 2024.
3. DS(IFD) emphasised that limits under DFPR, 2024 are required to be revised object head wise and suggested that proposed financial limits and comments of all the HoDs under this Department may be obtained alongwith the justification and difficulties being faced with the existing financial limits delegated vide order dated 23.01.2019. Accordingly, DS(IFD) has informed that till finalisation of revised limits, existing limits delegated vide order 23.01.2019 shall continue.
