In pursuance of powers delegated by the Ministry of Urban Development's O.M. No.1/17015/1/91-H.III, dated 4.9.91, sanction of the Chairman, CWC is hereby conveyed to the grant of advance of Rs.4,50,000/- (Rupees four lakh fifty thousand only) to Shri Goverdhan Prasad, AD, CWC for the purchase of a flat at Sector-82, Noida(U.P.) at an estimated cost of Rs.9,70,000/- from Central Govt. Employees Welfare Housing Organisation.

The amount sanctioned to Shri Govardhan Prasad, AD will be recovered from him in 150 instalments of Rs.3000/-p.m. from his salary from the month of May, 2004. The rate of interest will be 12.% in accordance with the Ministry of Urban Development's O.M. No170/5/5/97-E.III, dated 16.12.97. If conditions attached to the sanction including those relating to the recovery of amounts are sulfilled completely to the satisfaction of the competent authority, a rebate of interest to the extent of 2.5 % will be allowed. The interest on the above advance @9.5% amounting to Rs.2,65,406/- to be finally calculated by PAO, CWC will be recovered in further 59 instalments as below:

58 instalments @ Rs.4500/- P.M. 59th instalment @ Rs4406/-

The balance of principal amount and interest remaining unpaid, if any, at the time of his retirement or death preceding retirement will be recovered from the DCRG/Gratuity of Shri Prasad. The above House Building Advance is sanctioned to Shri Govardhan Prasad subject to the following terms and conditions:-

- i) The flat will be mortgaged by Shri Govardhan Prasad in favour of the President of India as Security for the above advance within 3 months of taking possession of the ready built flat failing which the advance together with interest thereon will be refunded to the Govt. forthwith unless an extension of time is granted by the competent authority.
- ii) Immediately after the purchase of the flat, he should get it insured at his own cost with the Life Insurance Corporation of India for a sum not less than the amount of advance sanctioned to him and should keep it insured against damage by floods, fire and lightning as laid down in Rule 7(b) of the Rules to regulate the grant of advance to Central Government servant

for building etc. of houses till the advance with interest thereon is fully repaid to the Government. He should have a clause inserted in the Mortgage Deed that he will not make any addition or alteration to the flat till he has fully repaid the advance together with interest thereon to the Government.

- iii) He will maintain the said flat in good condition and will continue to pay necessary insurance premium, municipal rates and taxes regularly. He will also facilitate inspection of the said flat annually as and when required in accordance with the said rules.
- iv) The cost of the flat over and above the ceiling limit advance will be borne by Shri Govardhan Prasad.
- v) In case Shri Govardhan Prasad wants to withdraw from the Scheme or is unable to meet the balance amount representing the difference between the HBA sanctioned by the Govt. and the actual cost of the house, the amount of HBA will be refunded forthwith to the Govt. by the Central Govt. Employees Welfare Housing Organisation.
- vi) With a view to safeguard the interests of the Govt., the Central Govt. Employees Welfare Housing Organisation will enter into a tripartite agreement.
- vii) The grant of the above advance is also subject to the fulfilment of the other conditions under the rules regulating the grant of advance to the Central Govt. servants for building etc. of houses.

Sanction of the release of Rs1,94,000/- (Rupees One lakh ninety-four thousand only) being the first instalment of HBA is hereby conveyed to Shri Govardhan Prasad,AD. The remaining amount of HBA will be released on receipt of Call Notice from Central Govt. Employees Welfare Housing Organisation and subject to the availability of funds.
